

Introduction

During 2008 the Agri-ProFocus partnership has developed its strategy for the period 2009-2012. In the document before you the partnership presents a summary of this new strategy. In the coming years Agri-ProFocus will build on the lessons of the first phase, and take on the challenge of starting from producer organisation (PO) demand and country ownership, while pro-actively developing a joint agenda among the membership. The quote above stimulates the Agri-ProFocus network to do this in a transparent, flexible and committed way.

The identity of Agri-ProFocus

Agri-ProFocus, founded in March 2005, is a partnership of Dutch donor agencies, credit institutions, fair trade organisations, training and knowledge institutions, and companies. The aim of Agri-ProFocus is provide more and better support to producer organisations in developing farmer entrepreneurship. The partnership has grown to 26 members from the original 19 and collaborates closely with the Directorate General for Development Cooperation (DGIS) of the Ministry of Foreign Affairs and the Ministry of Agriculture, Nature and Food Quality (LNV).

The Agri-ProFocus partnership stands for new ventures, new dynamics and for organising development cooperation beyond the boundaries of individual organisations. Leading value of the network is that support is based on the demand articulated by farmer led POs. In that sense Agri-ProFocus is not another new development organisation, but a practical implementation tool of and for its members.

Track record

At the end of 2005 DGIS approved the Agri-ProFocus strategic plan 2005-2008 for 1 million Euros. Since then member organisations have pooled human and financial resources for the implementation of PO support programmes and for various learning events and follow-up activities.

In total 18 trajectories have been facilitated and over 20 expert meetings organised on a variety of issues and themes regarding POs and agricultural development. What stands out in Agri-ProFocus' track record is a different way of working, namely sustainable joint support programmes instead of isolated individual actions.

Relevance and innovative perspective

In 2007 a global awareness emerged that agriculture has too often been overlooked as a catalyst for economic development and poverty reduction. The worldwide food crisis marks a global sense of urgency to take short- and long-term sustainable measures. In the Netherlands DGIS and LNV presented a joint policy paper on "Agriculture, Rural Entrepreneurship and Food Security". For the implementation of the proposed intervention areas an additional sum of at least 50 million Euro has been earmarked.

It is also increasingly recognised that producer organisations are essential for market-led agricultural development and producer competitiveness. In supporting POs the Agri-ProFocus network needs to take into account their diversity and hence the different roles they play, and to be sensitive to contextual differences like production environment and asset position that determine how farmers (are able to) organise themselves.

Recently there has been a strong call –from the Accra Agenda for Action as well as the Dutch Minister for Development Cooperation - for more collaboration and less segregation among development cooperation actors. Agri-ProFocus is responding to this by providing a network for joint action and learning.

Strategy and programme 2009 - 2012

It is within the above mentioned international and Dutch contexts that the Agri-ProFocus partnership positions its activities. The box below summarizes Agri-ProFocus' main strategic choices (and changes) for the next four years as compared to the previous period.

The overall goal of Agri-ProFocus is "promotion of farmer entrepreneurship" through enhancing the capacity of POs. The next phase will allow the partnership to build solid, transparent and action-oriented programmes at country level towards this goal. To do so in a coherent and effective way the Agri-ProFocus network will link to and support unfolding dynamics at country level with regards to agricultural policy dialogues, national and local priority setting, and allocation of resources.

For the period 2009 – 2012 the Agri-ProFocus partnership has fine-tuned its thematic focus to include: value chain development, access to financial services and products and sustainable food production. Respect for gender balance is a key criterion for all three themes. Learning and innovation will be linked to joint country programmes and trajectories, and hence to producer organisations' demand. The learning agenda will include practical topics that will enhance the knowledge of producer organisations and Agri-ProFocus network professionals alike.

Institutional collaboration

Agri-ProFocus' joint entrepreneurial programmes are essentially about matching demand from POs with supply from within the network. Success of collaboration depends on the explicit commitment of the member organisations to the partnership goals: to organise demand-oriented support services and infrastructure to POs beyond the limits of their individual organisations. This will mean a break with fragmented support. DGIS, LNV and the Royal Netherlands' embassies can play an important role in the Agri-ProFocus country programme approach. Close collaboration with the embassies will also assure the coordination and alignment with the delegations of the European Commission.

Regarding Southern partners, links with regional and national PO federations will be intensified through the membership. This will not happen in isolation, but with the objective to link PO support at different intervention levels and thus facilitate the inclusion of farmers' experiences and realities in the national and international debates on sustainable food production and global trade.

Agri-ProFocus 2009-2012 in a nutshell

Powerful POs are crucial actors in agricultural economic development, strengthening of democracy and as such key to poverty reduction and liveable rural areas. Cooperation among Agri-ProFocus members is an effective instrument to support POs in fulfilling their role.

Performance and internal organisation

The Agri-ProFocus partnership defines success at two levels:

- Under its direct 'span of control': activities and output, i.e. quality and quantity of joint programmes and learning & innovation
- Outside its direct 'span of control': effectiveness and impact, i.e. enhanced PO capacity for farmer entrepreneurship.

For the first level Agri-ProFocus has already established monitoring protocols and a database with information on general PO support by its members. In 2009 the Agri-ProFocus network will add tools for accountability and learning.

The network is facilitated by a support office consisting of 6 staff: director, 3 process facilitators, a management/project assistant, and one trainee. For the running costs of the Agri-ProFocus support office an average annual budget of 680.000 Euro is foreseen, to be financed by both member contributions and DGIS.
